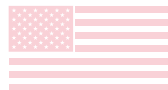

A screw-retained final restoration can also be selected.

*Price does not include round-trip overnight shipping (\$14 per box) or applicable taxes.

**Implant placement protocol positions the prosthetic platform of the implant 2 mm below the mid-buccal crest of the soft tissue for mandibular cases and 3 mm below for maxillary cases. For temporary components, this includes the following measurements: Custom temporary abutment – height of facial margin = 2 mm. BioTemps crown = 2 mm out of occlusion.
